FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

To increase production we propose to do the following work:

Pull rods and tubing. Run tubing & packer and test casing for leaks. 1.

- Run Welex series 2000 radioactivity log from 2865 to total depth. 2.
- 3. Visqueeze open hole with 100 sacks, displacing cement to 3860.
- 4. Sand-Jet approximately five planes with 5000 gallons of lease oil and
- 5000 lbs. of sand. Exact planes to be selected from log.
- Acidize open hole with 8000 gallons LST NEA acid in two stages using 1000 5. gal. jel acid and 1000 lbs. of crushed naphthalene as blocking material. 6.
- Swab, recover load oil, test, return well to production.
