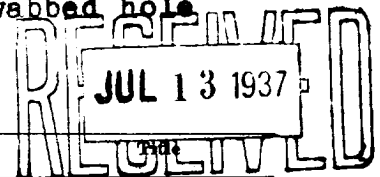
T. D. 3867' Lime.

Started swabbing above packer at 5:30 AM, 7-10-37 and swabbed hole dry in eighteen hours. No gas.
