APPLICATION OF THE BUFFALO OIL COMPANY REQUESTING TEMPORARY EXCEPTION TO PARAGRAPH 10 OF ORDER R-520 AS NEVISED AND AMENDED BY ORDER R-553, WHEREBY CASINGHEAD GAS MAY BE FLARED FROM THE STATE B LEASE, WELL NO. 3H, IN THE EUMONT OIL POOL, LEA COUNTY, NEW MEXICO.

Dear Sirs:

Comes now Buffalo Oil Company, a Maryland Corporation, with offices in Tulsa, Oklahoma and Artesia, New Mexico making application for temporary exception to paragraph 10 of Order R-520 as revised and amended by Order R-553 of the New Mexico Oil Conservation Commission Rules and Regulations whereby produced casinghead gas may be flared from their state B lease, well No. 3H in the Eumont Oil Pool, Lea County, New Mexico. In support of this application Buffalo Oil Company makes the following statements:

1. Buffalo Oil Company is the operator and sole owner of all merchantable oil and casinghead gas production underlying their State "B" lease which, in part, lies in the Eumont Oil Pool, Lea County, New Mexico. That part being in NE<sup>1</sup> of NW<sup>1</sup>/<sub>4</sub> section 36, T-20S, R-37E, NMPM, Lea County, New Mexico. That part being the only portion of Buffalo Oil Company's State 'B' lease lying within the horizontal limits of the Eumont Oil Pool.

2. That portion of Buffalo Oil Company's State "B" lease lying within the horizontal limits of the Eumont Oil Pool as described above is a 40 acre governmental quarter, quarter section and is exploited by a single producing oil well, Buffalo Oil Company's State "B" well No. 3H, completed within the vertical and horizontal limits of the Eumont Oil Pool. That said lease is wholly developed in the Eumont Oil Pool with no further development possible. - **X**
