- ② Cmt w/ 300 exs class "H" w/ 4% CaCl₂. Displace cmt to 70' below pkr.
- ③ POOH w/ pkr, Tag cmt @ 410' - drilled out cmt 410' - 780'.
- ④ Press. test casing @ 520 psi, bled down to 505 psi in 30 min. Sent chart in to NMOCB on 12-30-85.
- ⑤ Wash sand off RBP @ 3331' & POOH
- ⑥ Rig down on 12-20-85
