Propose to change zones from the Blinbry to the GSA intervals 3738'-3910' and acidize per the following:

Release packer and POH. RIH with CIBP and set at 5600'. Cap with 35' of cement. Displace hole up to 5050' with 12 bbls plugging mud. Set a 25 sx Class C cement plug above mud. POH and WOC. Displace hole and pressure test casing. RIH with 3-1/8" hollow carrier casing gun and perforate GSA intervals 3738'-55', 3776'-80', 3787'-96', 3807'-18', 3828'-30', 3840'-48', 3856'-67', 3873'-76', 3883'-90', 3896'-99' and 3900'-10' at 120° phasing and 2 JSPF. RIH with tubing with packer and set packer at 3600'. Swab test and evaluate. Run Base Gamma Ray Temperature Survey from 4100'-3500'. Acidize GSA with 7000 gals 15% NE HCL with additives. Flush to perfs with 21 bbls fresh 2% KCl. Run after treatment survey from 4100'-3500'. Swab back spent acid load and evaluate. Release packer and POH with tubing. RIH with 2-3/8" tubing with seating nipple on bottom and land seating nipple at 3930'. Run rods and pump.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
