Moved in service unit 5-16-84. POH with rods and pump. Ran 5-1/2" CIBP and set at 6450'. Capped CIBP with 35' of cement. Perforated 5683'-92', 5703'-07', 5610'-16', 5719'-21', 5726'-34', 5739'-45', 5748'-59', 5766'-74', 5779'-90' with 4 SPF. Ran packer, seating nipple and tubing to 5600'. Swabbed 6 hrs and recovered 21 BLW with no show of oil or gas. Acidized with 6500 gals 15% NEFE HCL and tagged with R/A material. Flushed with 25 BW. Swabbed 17 hrs and recovered 26-1/2 BLW. POH and ran seating nipple and tubing. Tailpipe landed at 5808'. Moved out service unit 5-24-84. Currently evaluating to continue recompletion efforts to another zone.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
