Propose to isolate extraneous water source per the following:

Move in service unit and POH. RIH with tubing and packer. Set packer at 5250'. Load backside and pressure test backside to 500 psi for 30 min. If pressure doesn't hold, begin moving packer up to isolate casing leak. If pressure test holds on backside and no casing leak is indicated above 5250', the release packer and POH. RIH with string mill and mill out tight casing at 5295'-5301'. RIH with tubing, packer, sub, and RBP. Set RBP at 6450' and set packer at 6100'. Load tubing and pressure up on tubing to 500 psi for 30 min. If pressure doesn't hold, begin to lower packer and isolate casing leak. Once casing has been tested below 6100', load backside and pressure up on backside to 500 psi for 30 min. If pressure doesn't hold, begin to move packer up and isolate casing leak.

\* Once casing leak is isolate, it will be cement squeezed and reported on next report.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
