Converted to a salt water disposal well in the following manner: Set 25 sx. cement plug across Tubbs perms. 6514-6314. Set 50 sx. cement plug across Blinbry perms 5950-5550. Perf. San Andres at 4547-4555, 4559-4568, 4615-4622, 4627-4632, 4656-4658, 4671-4676, & 4688-4700 w/2 JSPP. Treated perms. w/4,000 gal. 15% LSTNE acid. Perf. additional San Andres 4806-4812, 4826-4834, 4858-4862, 4981-4994, 5002-5018 & 5082-5092 w/1 JSPP. Treated perms 4806-5092 w/4,000 gal. 15% LSTNE acid in 5 stages using 40 ball sealers. On injection test, well took water at rate of 1800 BPD at 225 PSI.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
