It is proposed to recomplete this well to the Monument Tubb Pool as follows:

1. Clean out with bit and casing scraper to 6975'.
2. Run GR-CCL-CNL ;og frp, 6950'-2500' and perforate selected Tubb intervals from the log.
3. Set RBP at 6608' above the Drinkard.
4. Acidize Tubb perforations with 11,500 gals. 15% HCl.
5. Put well on production.
