DETAILS OF WORK

Set 7" casing at 3699 and cemented with 1725 sacks cement. Total depth of hole 3700' in line. Plug down at 2:20 P.M. 10-30-50. Top of cement behind casing 400' by Temperature Survey.

On 11-22-50, pressure tested casing with 1200# for 30 minutes. Final pressure 1180#. Found top of cement plug at 3640. Drilled out cement plug and pressure tested casing with 1200# for 30 minutes. Final pressure 1175#.
