DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Refer to notice of April 23, 1953. Open hole was jet perforated from 3738'-3828' with two holes per foot. Well was swabbed dry natural with slight show of gas. Section from 3685'-3828' was treated with 800 gallons of Jel and 3000 gallons Unisol acid. Formation broke down in three stages at 4000 lbs., 4500 lbs. and 4800 lbs. Injection rate was two barrels per minute. Swabbed well dry.
