Gentlemen:

Gulf Oil Corporation hereby makes application for approval of a non-standard gas proration unit comprising the S/2 of S/2 of Section 29, T20S, R37E, Lea County, New Mexico, and in support thereof states the following facts:

- (1) Gulf Oil Corporation is the owner and operator of an oil and gas lease known as the Bell-Ramsay "B" Lease and a portion of said lease comprises the 160 acres above described.
- (2) The Bell-Ramsay "B" #1 located 660 feet from the South line and 660 feet from the West line, Section 29, T20S, R37E, Lea County, New Mexico, was completed on March 8, 1950, as a gas well after plugging back from a total depth of 3840 feet to a depth of 3547 feet. The applicant proposes to use this well as the unit well and a plat of this proposed unit is attached hereto and designated as Exhibit "A".
- (3) On November 27, 1953, in compliance with Rule 12 of Commission Order R-370-4, the applicant filed Gas Well Plat on the Bell Ramsay "B" #1, Eumont Pool Gas Well and dedicated 160 acres to the well. The acreage dedicated consisted of 80 acres of Gulf's Bell-Ramsay "B" Lease described as the S/2 SW/4 Section 29, T20S, R37E, and 80 acres of Gulf's Amos B. Reeves Lease described as the N/2 SW/4 Section 29, T20S, R37E. A photostatic copy of the said November 27, 1953, Gas Well Plat is attached hereto and designated as Exhibit "B".

The applicant is herein proposing that in lieu of the 80 acres of the Amos B. Reeves Lease, described above that has heretofore been assigned to the Bell-Ramsay "B" #1 Gas Well, that an additional 80 acres of the Bell-Ramsay "B" Lease be assigned to said well.
