We acidized this well with 4000 gal in lime formation from 3750 to 3831. Casing set at 3708. Total depth of hole 3831 $\frac{1}{2}$. Production raised from 7 barrels of oil per hour to 9 barrels of oil per hour. Gas was not increased--still 1,000,000 cu. ft. No water. This work was done by Dowell Incorporated.
