FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

State "F" No. 2 was originally completed in the Grayburg as an oil well in 1936. It produced continuously until 1953 when production declined to a point where the well was non-commercial. An attempt was made to remove scale, using 500 gallon of acid. However, this did not restore production and no further remedial work was considered economically justifiable.

It is proposed to run a radioactive log, plug off open hole and recompleat as a gas well by perforating casing at approximately 3400' in the Queen section.
