Gentlemen:

In April 1954, Humble's State Aggies Well No. 4 was recompleted as a Ramont Gas Well and assigned an allowable based on a 160 acre unit described as follows:

Twp. 20 South, Rge. 37 East, Lea County, New Mexico
SW/4 of Section 31

Order No. R-520 which was drafted subsequent to this well's completion, adopted field rules for the Ramont Gas Field and established the standard gas proration unit as 640 acres. Under the provisions of Rule 5, Section (b), we are requesting that the unit be increased from 160 acres to 320 acres and described as follows:

Twp. 20 South, Rge. 37 East, Lea County, New Mexico
W/2 of Section 31

We submit the following information.

1. The non-standard gas proration unit consists of contiguous quarter-quarter sections.
2. The non-standard gas proration unit lies wholly within a single governmental section.
3. The entire non-standard gas proration unit may reasonably be presumed to be productive of gas.
4. The length or width of the non-standard proration unit does not exceed 5280 feet.
5. Humble Oil & Refining Company has full interest in all quarter-quarter sections composing the non-standard gas proration unit.
