

- Perforate Blinebry at 5700, 5706, 5719, 5728, 5733, 5744, 5775, 5789, 5800, 5815, 5823, 5836 & 5844. Acidized w/2000 gals. LTNE Acid & balls. SOT w/12,800 gal. lease oil, Adomite & 12,800# sand.
- Set FA Baker Production Packer at 5496'.
- Run "Triple String Flow Tube" on long string & set into FA Packer at 5496'.
- Run Blinebry string and triple complete.
