Sinclair Oil & Gas Company respectfully requests administrative approval to triple complete its J. R. Cone "A" No. 2 as a Drinkard, Tubb Gas, and Blinebry Oil, oil-gas-oil triple completion. The well is located in Unit L, Section 26, T-21-S, R-37-E, Lea County, New Mexico.

The well is presently a Blinebry Gas-Drinkard, gas-oil dual. It is proposed to squeeze the Blinebry Gas and recomplete in such a manner that the Drinkard Oil and Blinebry Oil zones can be produced thru parallel strings of 2 3/8" OD tubing and the Tubb Gas zone produced thru a flow tube to above the top packer and out the casing annulus. Therefore, this is also a request to cancel the Blinebry Gas allowable due this well and also the applicable Blinebry Gas-Drinkard Oil permit granted this well in order to put this present application in line for approval.

Enclosed you will find the appropriate Commission application forms, plat of the area, and diagrammatic sketch of the proposed triple installation.



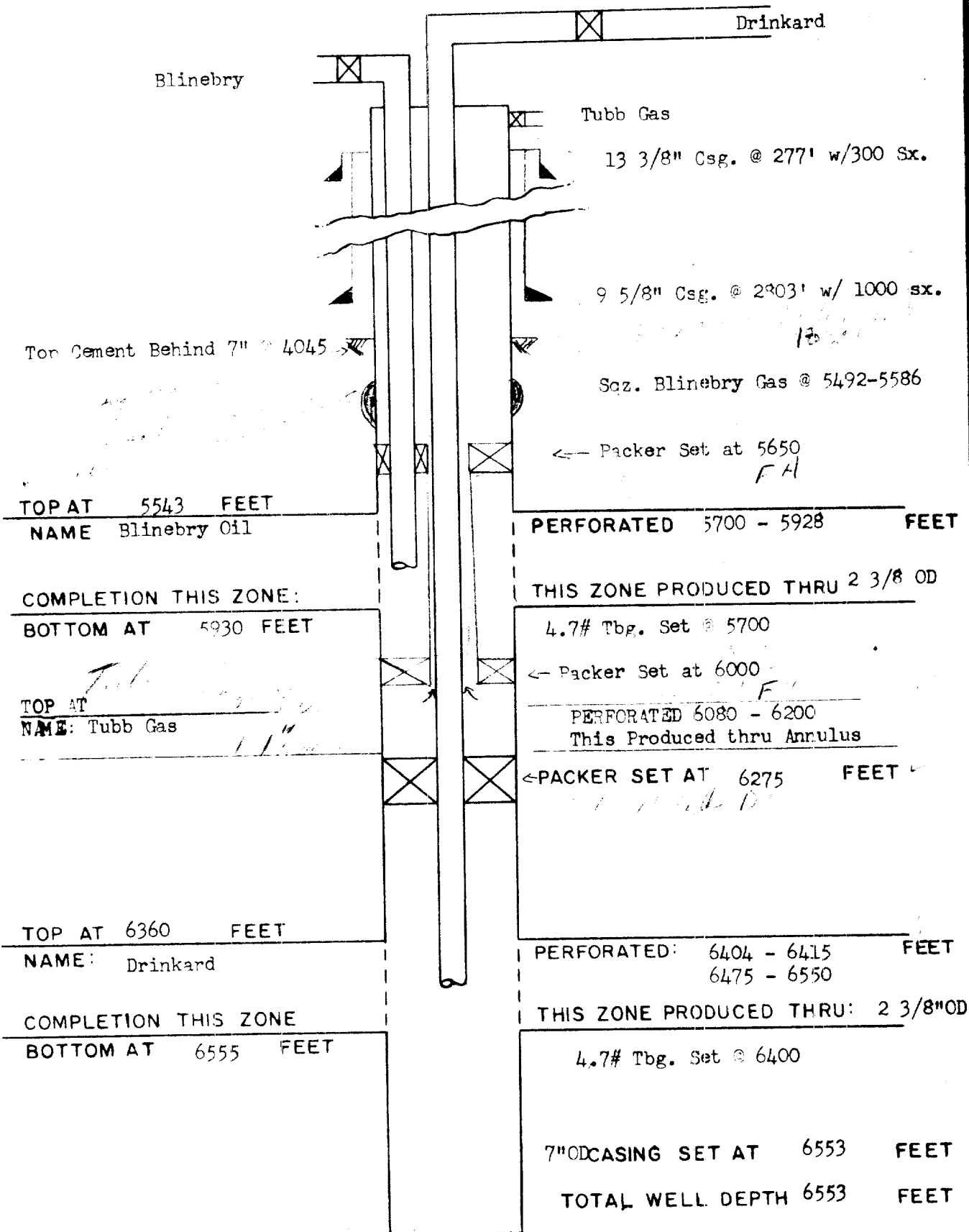
