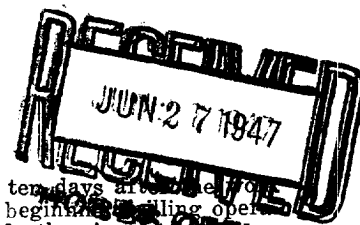

Set 8-5/8"OD casing at 2,809' and cemented with 1,400 sacks cement. Casing was tested with 1,200# pressure before and after drilling plug, was allowed to stand for 30 minutes to check for pressure decline. Held O.K.
