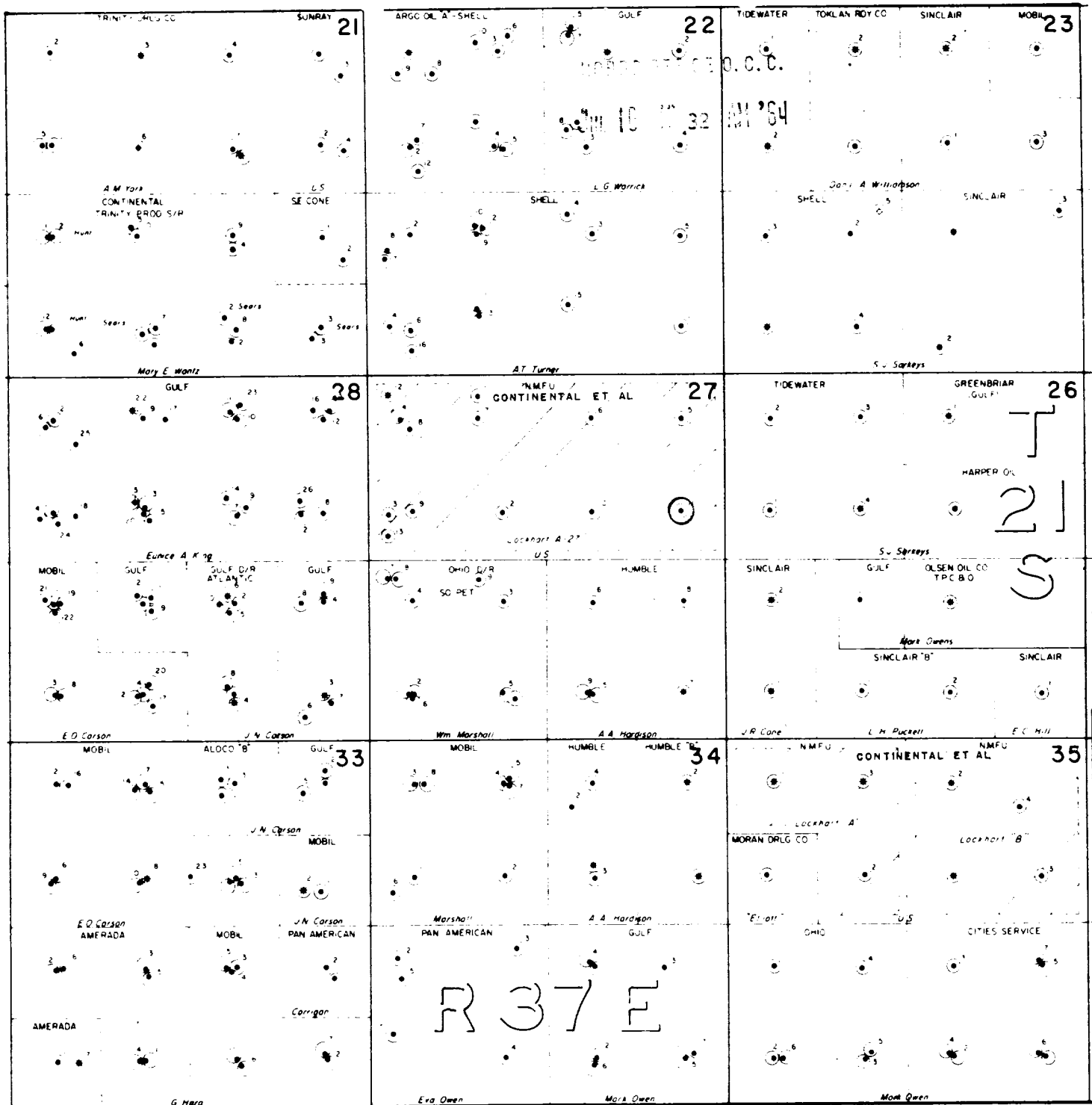

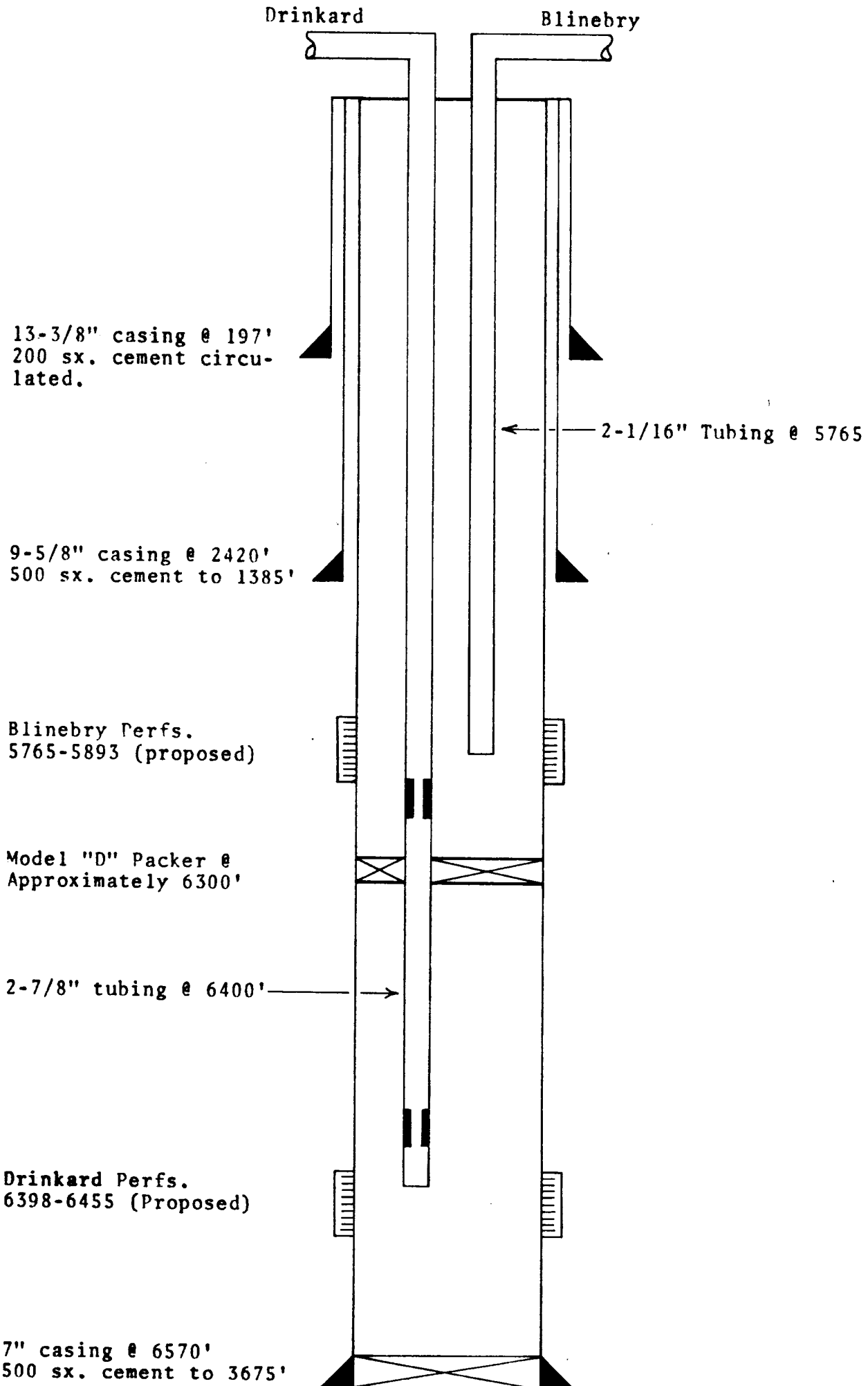
LOCKHART A-27 LEASE
