Intended Procedure: It is proposed to acid treat the well according to the following procedure: 1) Rig up, kill well and pull 2-1/2-inch tubing, 2) rerun 2-1/2-inch tubing with Lane Wells Hookwall packer, 3) circulate with oil and treat with 1,000 gallons of gel and 5,000 gallons of low tension acid, 4) swab out acid load and test, 5) tear down and place well on production.
