On November 2, 1947 ran 202 joints New 7" OD, 23#, 8 Rd Thd, Grade N#80 and J-55 Range 2, SS Casing. (27 joints N-80 on bottom and 175 joints J-55 on top) Tallies 6504', H-12', set 6516', w/1-7" Weatherford casing centralizer 6512'. Cemented by Halliburton w/700 sacks Lone star neat sack cement. Plug pumped to 6480'. Job started 4 AM and completed at 1 PM.

Propose to drill plug and test shut-off at 1 PM November 4, 1947.
