On February 23, 1949, ran 224 jts of new 7" OD, 8 Rd Thd, SS csg, from bottom up: 44 jts of A.O. Smith R-3 csg and 180 jts J-55 R-2 csg. Three 7" Weatherford csg centralizers spaced @ 7375', 7350' and 7315'. Tallies 7558', H-12', set @ 7570'. Cemented by Halliburton w/575 sacks 2% Aquagel and 125 sacks of common Portland bulk cement. Plug @ 7523'. Job started @ 8:30 a.m. and completed @ 5:45 p.m.

Propose to drill plug and test shut-off @ 5:45 p.m., February 25, 1949.
