Treated 7" casing perforations 5092' to 5188' down tubing with 2800 gallons of 28% NE acid. Flushed with 21 barrels of oil. Overflushed with 3200 gallons of oil. Average pressure 1800#, ISIP 1000#, after 5 minutes on vacuum. Swabbed and cleaned up and returned well to production.
