1. Drilled from plugged back total depth 7662' to 7825'.
2. Ran Schlumberger ES and Microlog surveys.
3. Underreamed from 7694' to 7825'.
4. Tested well.
5. Set Baker wire line production packer at 7675'. Ran tubing and circulating valves.
6. Flowed 242 bbls oil, no water 24 hours. Returned well to production (in McKee-Connell Pay).
