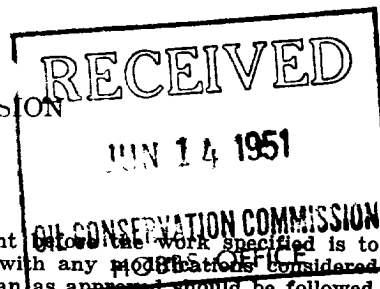

Will test and drill cement plug at approximately 2:45 A.M. 6-14-51.
