Gentlemen:

By this letter of application Gulf Cil Corporation wishes to state the following:

(a) That Gulf Oil Corporation 2. H. Carson "C" Ho. 4, located in the ME/4 SE/4 of Section 28, T-21-S, R-37-E, was completed August 29, 1947, at a total depth of 6612'. The attached Exhibit "A" shows the location of this well on the Gulf Oil Corporation J. N. Carson "C" Lease together with the location of all offset wells.

(b) That subject well has 7" casing set at 6485! and commented with 700 sacks of comment. The well is an oil well producing from the open hole interval from 6485-6612! in the Drinkard Fool.

(c) That the applicant proposes to dually complete the well in the following manner:

(1) Perforate the 7" casing within the approximate interval of . 5535-5760' in the Blinebry Gas Pool.

(2) Set production type packer below these perforations at approximately 5850' to separate the two pay zones.

(3) Produce the Drinkard Fool oil through the tubing and the Blinebry gas through the tubing-casing annulus.

(d) That the granting of this application for permission to produce the well as a dual completion with gas from the Blinebry and oil from the Drinkard is in the interest of conservation and the protection of correlative rights.

(c) That the applicant will comply with all rules and regulations of the New Mexico Oil Conservation Commission to maintain separation of production from the two pay zones.
