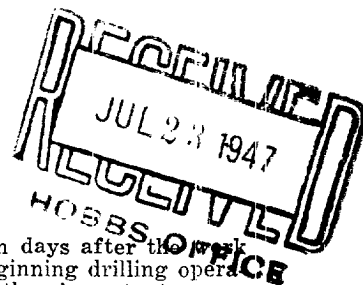

It should be signed and sworn to before a notary public for reports on beginning drilling operations, results of shooting well, results of test of casing/shut off, result of plugging of well, and other important operations, even though the work was witnessed by an agent of the Commission. Reports on minor operations need not be signed and sworn to before a notary public. See additional instructions in the Rules and Regulations of the Commission.

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The hole was washed down and the casing tested with 1200" pressure applied for 30 minutes. The plug was drilled and the casing tested with 1200# pressure applied for 30 minutes. Both tests were OK, and after approval of Mr. Yarrbrough, State Oil and Gas Inspector, preparations were made to drill ahead.

The temperature survey shows the top of cement behind a 9-5/8" casing at 1365' from the surface.
