(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to return well to production it is proposed to fracture treat as follows:

1. Pull 2-3/8" tubing. Run steel line measurement, if warranted clean out with sand pump.
2. Run 2-7/8" tubing with formation packer set at approximately 3640'. Treat formation below packer with 6000 gallons gelled lease oil with 1# sand per gallon. Followed with 750# crushed mothballs in 18 bbls of oil, followed with 6000 gallons gelled lease oil with 1# sand per gallon.
