Gentlemen:

In compliance with Rule 30, Order No. R-1670 which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests exception to Rule 5A of Order No. R-1670 for the approval of a Non-Standard 40-Acre Blinebry Gas Proration Unit covering the SE/4 NW/4 Section 28, Township 21 South, Range 37 East, Lea County, New Mexico.

In support of this application, the following facts are submitted:

- (1) Applicant's Eunice King Well No. 5, located 1874 feet from the north and west lines of Section 28, Township 21 South, Range 37 East, is completed in the Blinebry Gas Pool and is assigned a Non-Standard 80-Acre Gas Proration Unit covering the S/2 NW/4 of this Section 28.
- (2) Applicant's Eunice King Well No. 24, located 766 feet from the west line and 2086 feet from the north line of this Section 28, has been completed as a Blinebry oil well.
- (3) The proposed Non-Standard Gas Proration Unit consists of a single quarter-quarter section and lies wholly within a single governmental quarter section.
- (4) The entire Non-Standard Gas Proration Unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) The length or width does not exceed 2640 feet.
- (6) All operators within 1500 feet of the unit well have been furnished a copy of this application. Gulf owns all the leasehold interests in the quarter section in which the proposed Non-Standard Unit is located.

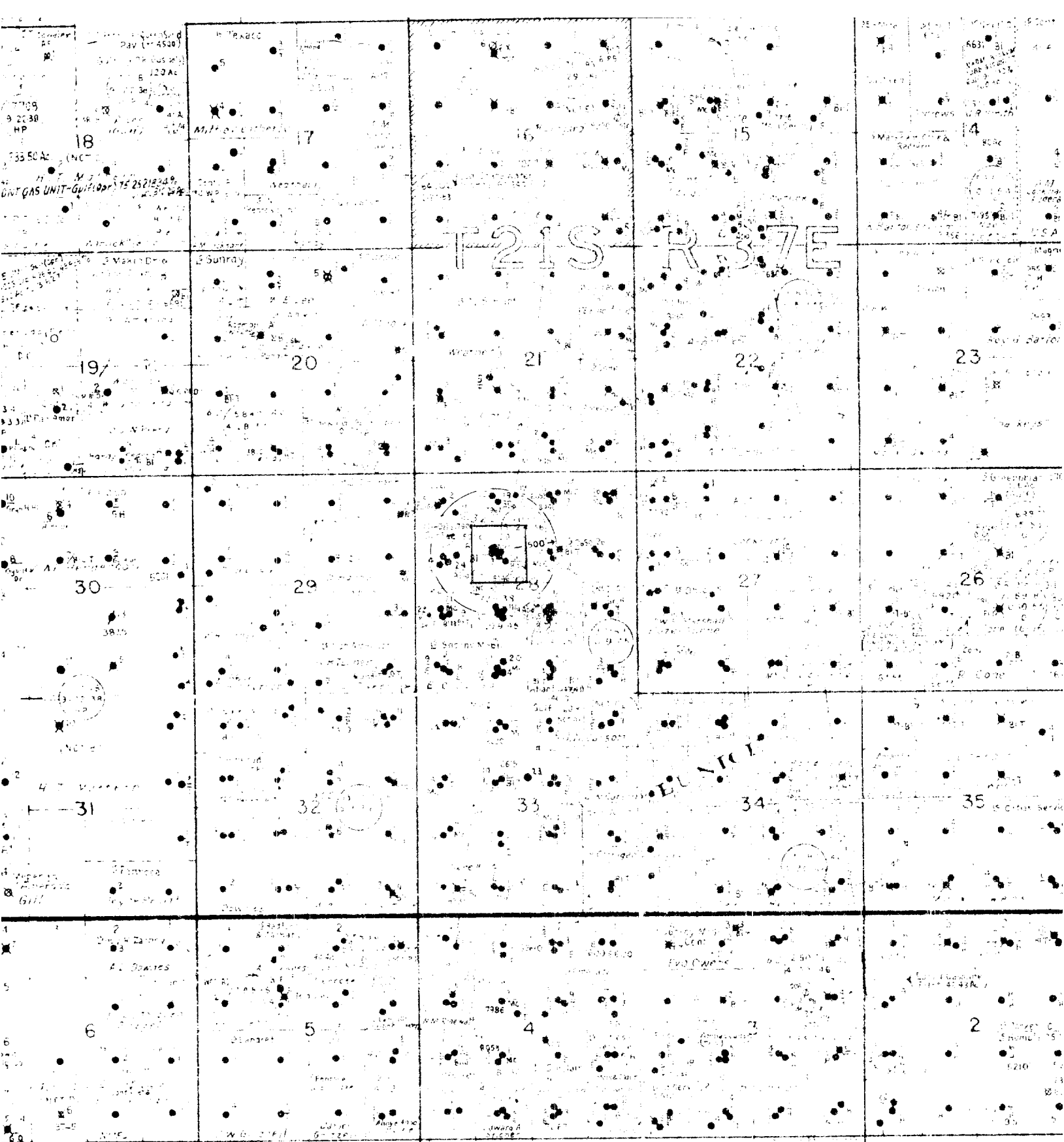
