FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On December 22, 1948, ran 8 jts of new 13-3/8" OD spiral weld R-3 slip jt casing and 48#, 8 Rd Thd, R-2 seamless steel csg. From bottom up: 1 jt of 48# 8 Rd Thd, H-40, csg, 6 jts Armo SJ csg, and 1 jt 48#, H-40 on top. Tallies 300', H-17', set @ 317'. Cemented by Halliburton with 300 sacks neat bulk cement. Plug @ 297'. Cement circulated OK. Job started @ 4 p.m. and completed @ 6:45 p.m.

Propose to drill plug and test shut-off @ 6:45 a.m., December 24, 1948.
