Chevron U.S.A. Inc. respectfully requests administrative approval for simultaneous dedication of the Eunice King Well No. 14 with the Eunice King Well No. 13 in the Tubb Oil and Gas Pool.

Chevron U.S.A. is planning to recomplete the Eunice King Well No. 14 in the Tubb (Pro Gas) zone. The well currently is completed in the Blinebry Oil and Gas Pool. The location of the proposed recompletion is 1874' FNL and 2086' FEL (Unit G) Section 28, T21S, R37E, Lea County, New Mexico.

Eunice King Well No. 13 is dedicated to a standard 160-acre Tubb Gas Proration Unit which consists of the NE/4 of Section 28, T21S, R37E. Well No. 13 is located 554' FNL and 554' FEL (Unit A) Section 28, T21S, R37E.

Well No. 14 was drilled in 1949 as a Hare-Simpson producer. The well was deepened to the Connell sand in 1954 and placed on dual production (Hare/Connell). The Connell sand was P&A'd in 1986. In 1990, the Hare-Simpson was P&A'd and the Blinebry zone completed. Current production from the Blinebry is 2 bopd 1 bwpd 30 mcfpd.

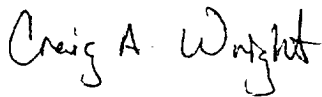
Chevron U.S.A. respectfully requests authorization to simultaneously dedicate Tubb Gas Pool production to a standard 160-acre gas spacing and proration unit comprising the NE/4 of Section 28, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, from Eunice King Wells Nos. 13 and 14.

Eunice King Wells Nos. 13 & 14 will require unorthodox gas well locations for the subject 160-acre unit.

A copy of this administrative application is being provided to our offset operators via Certified Mail. Attached is a commercial map and a Form C-102 plat illustrating the proration unit acreage and well location. Also included is a copy of the letter sent to our offset operators.

Ladies and Gentlemen:

This is to inform you as an offset operator that Chevron U.S.A. Inc. has applied for administrative approval for simultaneous dedication of the Eunice King Well No. 14 with the Eunice King Well No. 13 in the Tubb Oil and Gas Pool.

Chevron U.S.A. is planning to recomplete the Eunice King Well No. 14 in the Tubb (Pro Gas) zone. The well currently is completed in the Blinebry Oil and Gas Pool. The location of the proposed recompletion is 1874' FNL and 2086' FEL (Unit G) Section 28, T21S, R37E, Lea County, New Mexico.

Eunice King Well No. 13 is dedicated to a standard 160-acre Tubb Gas Proration Unit which consists of the NE/4 of Section 28, T21S, R37E. Well No. 13 is located 554' FNL and 554' FEL (Unit A) Section 28, T21S, R37E.

Well No. 14 was drilled in 1949 as a Hare-Simpson producer. The well was deepened to the Connell sand in 1954 and placed on dual production (Hare/Connell). The Connell sand was P&A'd in 1986. In 1990, the Hare-Simpson was P&A'd and the Blinebry zone completed. Current production from the Blinebry is 2 bopd 1 bwpd 30 mcfpd.

Chevron U.S.A. plans to simultaneously dedicate Tubb Gas Pool production to a standard 160-acre gas spacing and proration unit comprising the NE/4 of Section 28, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, from Eunice King Wells Nos. 13 and 14.

Eunice King Wells Nos. 13 & 14 will require unorthodox gas well locations for the subject 160-acre unit.

Attached is a commercial map and a Form C-102 plat illustrating the proration unit acreage and well location.
