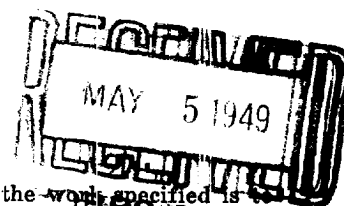

## FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On May 3, 1949, ran 257 jts of new 7" OD, 26# and 23# N-80 & J-55, R-1, 2 & 3 SS casing w/long T&C. From bottom up: 38 jts of 26#, N-80, R-1 casing, 46 jts of 23#, N-80, R-2 casing, 172 jts 23#, J-55, R-2 casing, one jt of 26#, N-80, R-2 casing w/one 7" Baker centralizer spaced @ 7500'. Tallies 7929', H-13', set @ 7942'. Cemented by Halliburton w/575 sacks 2% HOWCO Gel and 125 sacks common Portland bulk cement. Plug @ 7891'. Job started @ 8:30 a.m. and completed @ 8:30 p.m.

Propose to drill plug and test shut-off @ 8:30 p.m., May 5, 1949.
