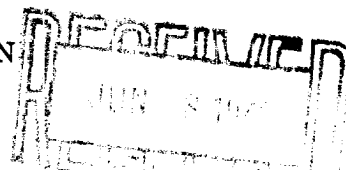

On June 5, 1949, ran 215 jts of new 7" OD, 23# & 26#, 8 Rd Thd., N-80 & J-55 range 2 & 3, SS casing. From bottom up: 5 jts of N-80-26# R-3 csg, 47 jts of 23# N-80 Range 3 casing, 162 jts of 23# J-55 Range 3 casing and one jt of 26# N-80 casing w/one 7" casing centralizer @ 7350'. Tallies 7586', H-14', set @ 7600'. Cemented by Halliburton w/575 sacks of 2% Howcogel and 125 sacks of common Portland bulk cement. Plug @ 7564'. Job started @ 10:45 a.m. and completed @ 3:30 p.m.

Propose to drill plug and test shut-off @ 3:30 p.m., June 7, 1949.
