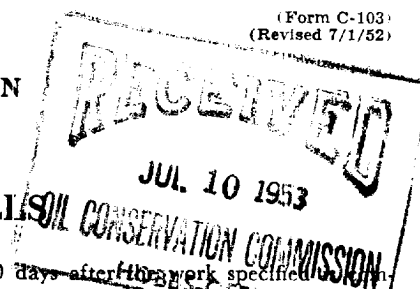

Installed 20' Pelton Model 412 - 8.5- 2 G-P pumping unit w/100 HP Electric Motor. Ran 257 jts. 8031.64' tubing. Tubing set at 8045'. Seating shoe at 8007'. Perfs. at 8008-12'. Ran pump & rods.

Pumped on Oil Conservation Commission test 108 bbls oil 353 bbls water thru 2-7/8" tubing in 24 hrs, 7 x 19-1/2 spm. Gas Volume 66,600 cu. ft. GOR 617. Allowable before equipment replacement none. Allowable after equipment replacement 105 BOPD.
