  - 3. Pressure test csg with 1000 psi. Run 2-3/8" tbg with Dowell's Abrasijet tool. Perforate Penrose Skelly as determined from log.
  - Run 2-7/8" tog with Baker full bore pkr. Squeeze 500 gals 15% NE acid thru perfs. 4. Treat perfs with 20,000 gals frac.
  - 5. Swab and test.
