It is proposed to abandon Hare Pool and recomplete in the Wants Abo as follows:

1. Run GI BP on electric line and set at approximately 7300'. Dump 2 sacks cement on BP.
2. Pressure test casing with 1000 psi. If OK, perforate intervals 7162-69', 7176-87' and 7191-7224'.
3. Acidize perforations with 6000 gals 15% acid with LST-5 and R-1500 additives.
