Sinclair Oil & Gas Company respectfully requests administrative approval to dual complete its J. R. Come "B" Well No. 2 as a dual Drinkard-Blinebry oil-oil dual. The well is located in Unit O, Section 26, T 21 S, R 37 E, Lea County, New Mexico.

The well is presently completed as a Brinkard oil well. It is proposed to dually complete this well in such a manner as to permit the Drinkard and Blinebry oils to be produced through parallel strings of 2" OD tubing.

Also, this Blinebry acreage is dedicated to the gas unit of our J. R. Cone "A" No. 2 well. Therefore, upon approval of this dual application, the appropriate Commission forms will be filed to reduce the gas allowable of the aforementioned unit to exclude this acreage being changed to Blinebry oil.
