FULL DETAILS OF PROPOSED PLAN OF WORK
 (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

It is proposed to acidize well in attempt to increase production as follows:

- 1. Kill well with water and pull 2-3/8" tubing.**
- 2. Run steel line measurement to 6611' to check for cavings; CO if necessary.**
- 3. Run 2-3/8" tubing w/ Lynes packer and set packer at 6530.**
- 4. Acidize below packer w/ 3000 gallons 15% NE acid.**
- 5. Pull 2-3/8" tubing and packer; re-run 2-3/8" tubing, return well to production.**
