Cemented by Halliburton with 575 sacks 2% Aquagel and 125 sacks Trinity Portland bulk cement. Plug at 6448'. Job started 10:25 a.m. and completed 7:10 p.m.

Propose to drill plug and test casing shut-off at 7:10PM March 15, 1948.
