DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran Steel Line Measure and found cavings at 7657', 218' sand in hole. Ran 252 jts 7634' 2-7/8" tubing w/6" Hughes bit, cleaned out 7657' to 7722'. Cleaned out from 7859-7875'. Ran steel line measure & found cavings at 7837', 38' sand in hole. Ran 214 jts 6491' 2-7/8" tubing. Tubing set at 6498' Seating nipple at 6484'. Perf. at 6496-98'. Ran pump and rods.

Pumped on Oil Conservation Commission test 58 bbls oil, 96 bbls water thru 2-7/8" tubing in 24 hrs. Gas Volume 8,900 cu. ft. GOR 153. Tubing pressure 30#. Casing pressure 30#. Allowable remains unchanged, 71 BOPD.
