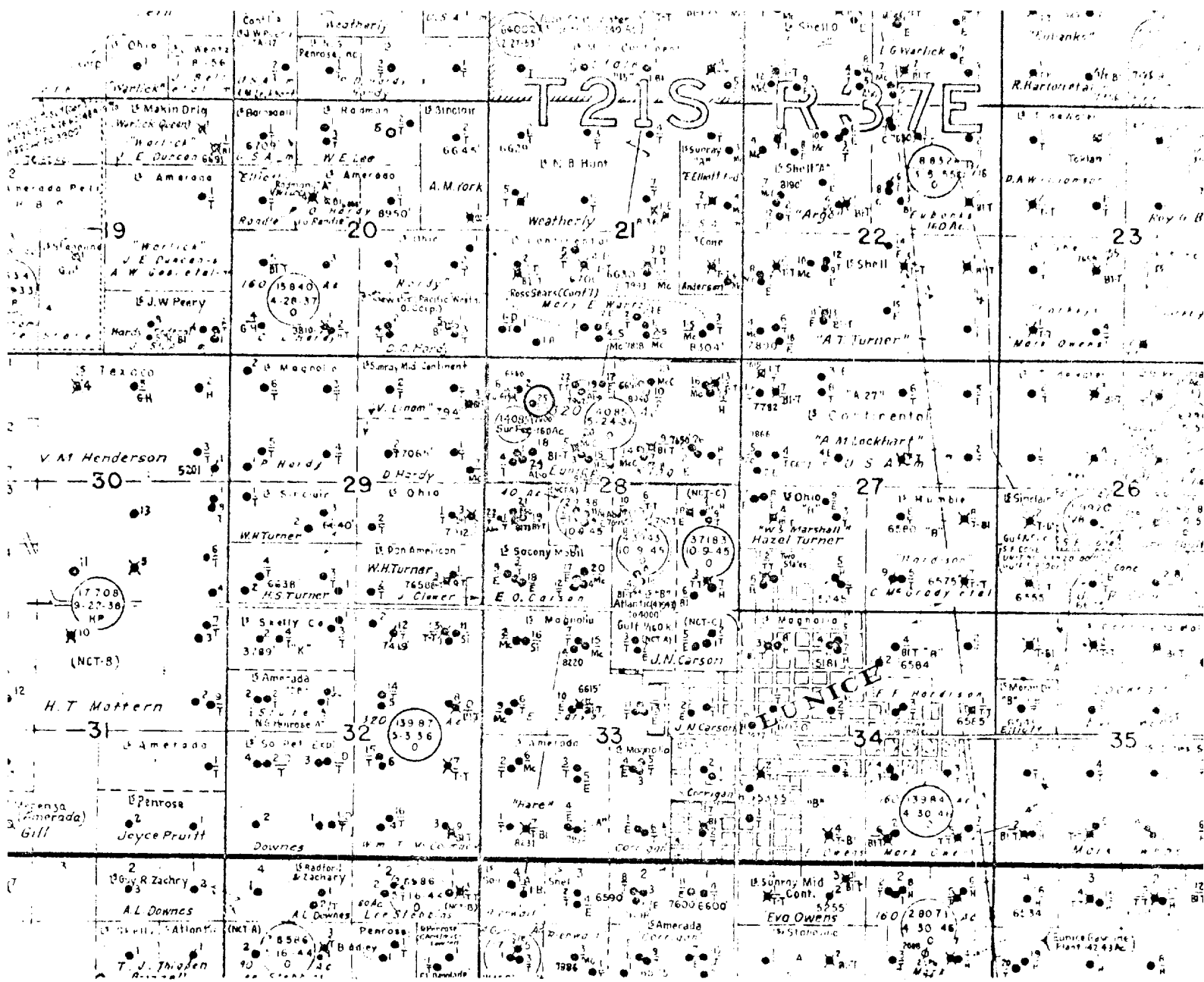

▬ Pertinent Gulf Lease

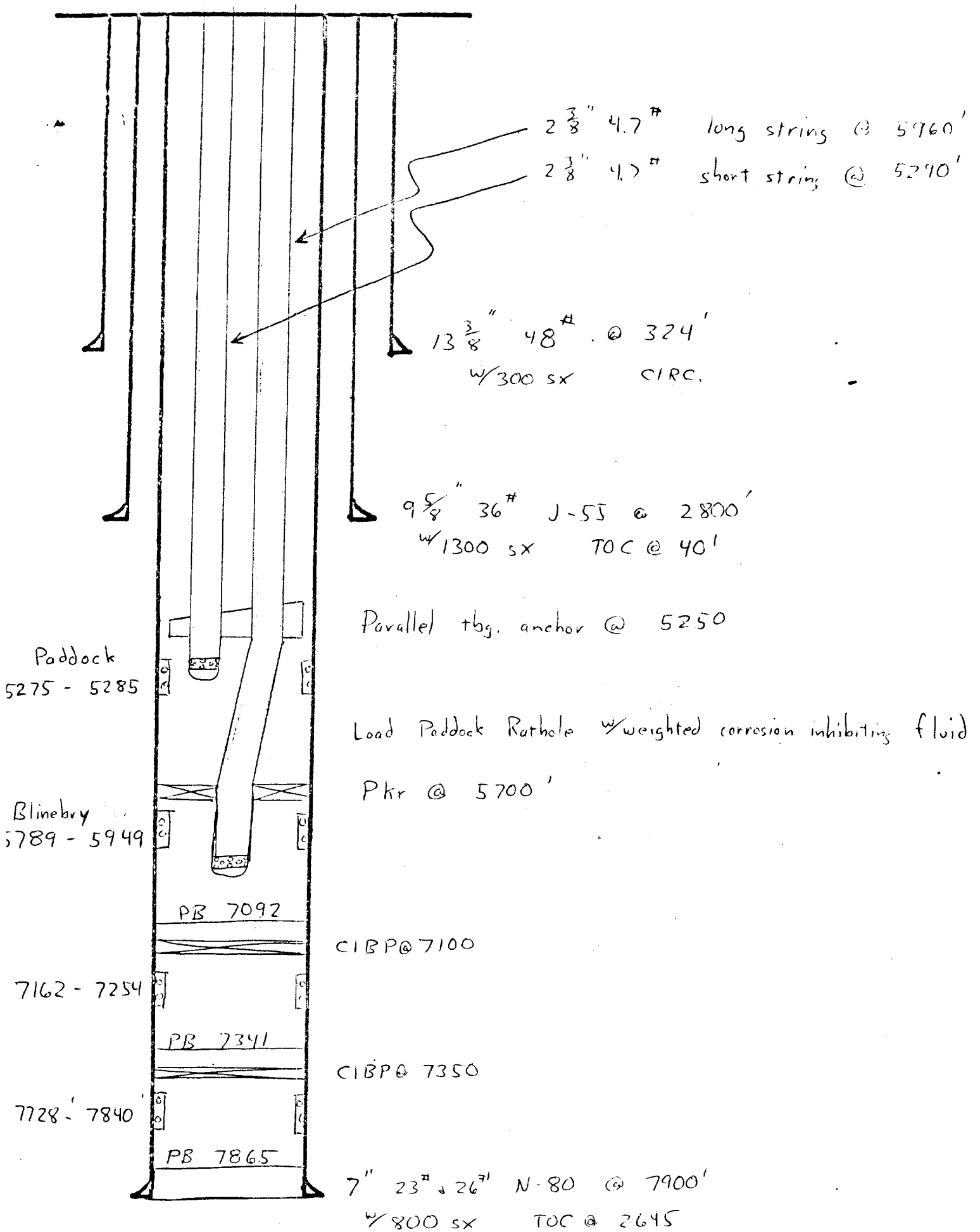
