This well was shut in on June 10, 1970 because it was uneconomical to produce. Propose to plug & abandon the present Penrose Skelly Grbg OH interval 3618-3791' & recompleate in the Eumont Queen Gas in the following manner:
1. Rig up, kill well & install BOP.
2. Make trip w/6 1/4" bit & 7" scraper to 3575'.
3. Set 7" 24# cmt retr on tbg @ 3560' GR.
4. Squeeze OH w/150 sx Cl C cmt w/4% gel & 8# salt/sk.

Proposal to plug back & recompleate in Eumont Queen Gas filed separately on Form C-101.
