Tested squeeze job to 800# for 15 min, OK. Reran tubing, installed 2" valve in top of tubing. Job complete @ 5:00 PM 1/13/73. Tubb Zone P & A, Drinkard zone turned over to Central Drinkard Unit Operated by Gulf Oil Corporation. This well will be known as Central Drinkard Unit Well #162.
