NOTE: Central Drinkard Unit Well #107, producing from the Drinkard zone and operated by Gulf Oil Co., is dually completed with Sun's D. Hardy #2. The Penrose Skelly Zone was reviewed in 1966, and was determined to be beyond its economic limit with no possibilities for recompletion or stimulation. After plugging the Penrose, Gulf will convert the well to injection in the Drinkard.
