Ran 119 joints (3752') 5-1/2" OD 24# Gr J-55 SS casing. Set and cemented at 3800' with 375 sacks 45 Gel cement. Plug at 3767'. Maximum Pressure 850#. Job completed 6:45PM 8-27-57.

After waiting over 36 hours, tested 5-1/2" casing with 1000# for 30 minutes. No drop in pressure. Drilled cement plug from 3767-3800'. Tested below casing shoe with 1000# for 30 minutes. No drop in pressure.
