Detailed account of work done, nature and quantity of materials used, and results obtained.

It was attempted to dually complete subject well in Wants Abo zone with existing Drinkard zone as follows:

1. Drilled calceal & cement 6666-7398'. Ran GR-N log.
2. Ran 7" Howco cement retainer on 2-3/8" tbg set at 7283'. Squeeze cemented perfs 7305-7400' with 250 ex Inco cement with 1/2" Tuff Plug per sack last 50 ex, in 10 stages. Maximum pressure 4350#. WOG.
3. Perforated 7" csg 7270-60', 7256-46', 7240-34', 7198-86', 7170-60', 7148-40' with 4, 1/2" JHFP.
4. Ran 2-7/8" tbg open ended to 7275'. Packer at 7120'. Spotted 500 gals 15% NE acid. Squeezed into perfs 7140-7270'. AIR 2.4 BPM. TP 3400#. Treated same perfs down 2-7/8" tbg with 12,000 gals Iron acid in 6 equal stages. AIR 6.8 bpm. TP 3500-3100#.
5. Scrubbed and tested.
6. Treated csg perfs 7140-7198' down 2-7/8" tbg with 6000 gals 15% NE acid in 3 stages. AIR 6.5 BPM. TP 3600-2300#.
7. Scrubbed and tested. Could not recover oil in commercial quantity.

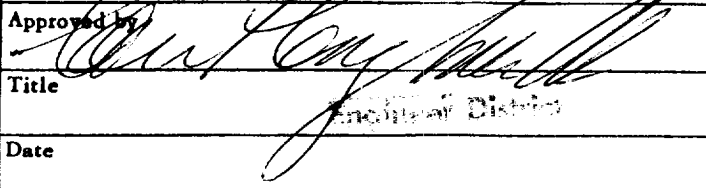
