Total tallies 6524', H-12', set @ 6536. Cemented by Halliburton with 575 sacks of 2% bulk and 125 sacks of neat sack cement. Plug @ 6487'. Job started @ 8:30 a.m. and completed 5:15 p.m.

Propose to drill plug and test shut-off @ 5:15 p.m., December 16, 1948.
