Gentlemen:

With this letter, Skelly Oil Company, is petitioning the Secretary of the New Mexico Oil Conservation Commission for administrative approval for an order granting permission to dual complete their State "K" Well No. 3 as a gas well in the Tubb Gas Fool and an oil well in the Drinkard Oil Pool and for an order establishing an 80 acre non-standard gas proration unit in the Tubb Gas Fool, Lea County, New Mexico, and in support thereof does state:

- 1. That the petitioner is the owner and operator of an oil and gas lease held on the 80 acres confined by the N/2 NW/4 Section 32, Township 21 South, Range 37 East, N. M. P. M., Lea County, New Mexico, and concerns but a single royalty owner.
- 2. That the petitioner's State "K" No. 3 well is located 480° from the north and 2160° from the west lines of the section and was completed in January 1948 as an oil well in the Drinkard Oil Pool.
- 3. That the petitioner will dually complete their State "K" No. 3 in a manner described below.
 - a. Set a Baker Model "D" production packer at 6400.
 - b. Perforate the Tubb in the interval 6100'-6300' within the vertical limits of the Tubb Gas Pool.
 - c. Run 2 3/8" OD tubing and produce the Drinkard oil through tubing and the Tubb gas through the tubing casing annulus.

- 4. That the manner in which the petitioner has set out to complete the proposed dual is both mechanically feasible and practical and conforms to the Commission's policies and specifications as pertaining to gas-oil dual completions in the State of New Mexico.
- 5. That a diagramatic sketch showing the anticipated producing intervals and the physical equipment to be used in dually completing this well is attached hereto.
- 6. That the entire N/2 NW/4 of Section 32-218-37E can be assumed to be productive of gas by virtue of offset production.
- 7. That a plat showing the above described lands and all offset properties indicating lease ownership and well locations is hereto attached.
- 8. That all offset operators are hereby notified by a copy of this application.
- 9. That the above statements are true and complete to the best of my knowledge.

Wherefore, the petitioner request that, in the interest of conservation and protection of correlative rights, the Secretary of the Commission grant an order pursuant to Rule 112-A, Order No. R=316, by which the petitioner may dually complete their State "K" No. 3 in a similar manner to that described above and also grant an order for an 80 acre non-standard Tubb Gas Unit.
