DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Hole was drilled to 3778' and before treating swabbed estimated 5 Bbls. oil per hour. On August 15th well was treated with 2000 gallons Dowell XX acid. After acid well cleaned to pits 3 hrs. and then flowed to tanks 15 Bbls. oil per hour for 3 hours. Well shut in 12 hrs. and then flowed average 11 Bbls. oil per hour for 4 hours. Well then flowed 65 Bbls. oil in 9 hours with 220,000 gas.

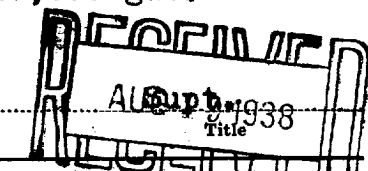
