FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

It is proposed to abandon Brunson Oil zone and recomplete in the Paddock Oil zone as follows:

1. Run bridge plug on wire line and set at approximately 7300'. Dump 2 sacks cement on top.
2. Pressure test casing to 1000 psi. If OK, run GR-N log with collar locator from 5500' to 4500'. Area to be perforated will be selected from this log.
3. Treat with 500 gallons mud acid. If warranted, treat with 1000 gallons 15% NE acid. Swab and test.
